According to the Accepting Schools Act, bullying:

- Is an aggressive behaviour
- Has an intent, or reasonable assumption to cause harm (to the individual, his or her reputation or property)
- Is typically repeated
- Involves a real or perceived power imbalance
- May have a negative impact on the learning environment of the school

Developing the Bullying Prevention Plan with your Safe Schools Team

The Accepting Schools Act requires each school to have a Bullying Prevention Plan. Please complete the Bullying Prevention Plan Template found within this resource and on the Safe Schools Portal.

The purpose of this template is to assist Safe Schools Teams in developing a Bullying Prevention Plan in order to "integrate Safe Schools' strategies in a sustainable manner." (Jaffe, Crooks & Watson, 2009) Based on your School Climate Survey data, The School Assessment Checklist, (found in Jaffe et al, pp 47 – 56) as well as other data at your disposal, your Safe Schools Team will identify strengths and areas of growth for your school and then develop a plan to address the needs. The plan will include the programs and resources required for implementation.

Every school must have an Annual Bullying Prevention Plan that includes a mechanism for students, parents and community members to report incidents of bullying.


With your Safe Schools Team, collect your school data. This could include:

This data provides your Safe Schools Team with evidence to lead an informed discussion regarding improving the climate in your school. Your Team will develop a SMART goal and indicators of success.

Create a SMART Goal for Bullying Prevention. For example:

By December 2014, the percentage of student responses indicating "never feeling safe at school" on the School Climate Survey will decrease to less than 1%.



- share with your staff and implement


